



Standing Rules

- Marion County Republican Party Mission
 - The mission of the Marion County Republican Party is three fold, to register republicans, to elect republicans to office and to find good people to register and elect. This mission is in service to upholding the US constitution and the Oregon Constitution. In addition, represent the interests of 62,000 Republican voters.
- Disposition of the Marion Couty Republican Party
 - MCRCC is an all-Volunteer organization.
 - o The MCRCC is an independent political action committee, not a charitable organization.
 - MCRCC is a private organization. PCPs are not considered public officers by law. (ORS 248.015(7))
 - Elected Officers of the MCRCC have full rights of privacy.
- Purpose of the code of conduct
 - This Standing Rules Set is establishing a set of values, rules, standards, and principles for the Marion County Republican Party.
 - This *code of conduct* is an important part of establishing an ethical culture in the party and defining principles that are fundamental to the success of the party.
- Compliance with laws or laws relevant to member rights
 - o Comply with ORS 248 Political Parties (except ORS 248.012 248.315, except ORS 248.015)
 - o Comply with ORS 260 Campaign Finance
- Improper behaviors and their consequences
 - Privacy
 - Being in the MCRCC depends on our trust in one another. Some discussions may be sensitive or contain sensitive information, so what's said in the MCRCC should stay in the MCRCC.
 - The only officially released records of an MCRCC meeting are the minutes.
 - Social media and Website Standing Rules
 - Social Media and website tools are intended for collaboration and networking among the PCP's of the Marion County Republican Central Committee.
 - Social Media and website tool posts that violate the guidelines will be deleted. The member will be given a warning, and a 2nd violation will result in removal from the group.
 - Social Media Standing Rules
 - The following set of rules/guidelines has been put in place to protect all members.
 - NONE of the following is acceptable behavior:
 - Negatives posts about Marion County Republicans, ORP, or Republican candidates.
 - Vulgarity, trolling or anything else that is mean or degrading.
 - Name calling and mean spiritedness
 - All posts should be relevant to Marion County PCPs.
 - No blocking of admins.

- As a secret group, there will be NO screenshots of anything on our page shared outside this group. This includes PM, your FB page, other groups. Doing so will be cause for immediate removal from the group.
- Posts that violate the guidelines will be deleted. The member will be given a warning and an 2nd violation will result in removal from the group.
- If a member has been banned, no posts from that person may be shared to the page by any other member on behalf of the banned member.
- As a private organization, there will be NO screenshots of anything on social media or
 website tools shared outside of the MCRCC. This includes texts, PM, your FB page, and
 other groups. Doing so will be cause for immediate removal from all MCRCC social
 media and the website.

Indecorous behavior

- Bullying, targeting, written harassment or verbally attacking a member of the MCRCC is not allowed and will not be tolerated.
- Disruptive behavior during MCRCC events.
- Threats of physical violence between members of the MCRCC are strictly forbidden. The member initiating the threat will be subject to immediate disciplinary action.
- Sexual harassment will not be tolerated. The offending member will be subject to disciplinary action.

Personal Conflicts of Interest

• If there is an issue between central committee members that would affect their ability to function as a team, inform the Chair with the minimum necessary information required to resolve the issue.

• Intoxication and drug use

o Any Central Committee member attending a central committee meeting or other event must not be intoxicated or under the influence of drugs.

• Appearance and decorum

- All Central Committee members should present a professional appearance when attending MCRCC meetings and other events.
- All Central Committee members should present in a decorous manner as described in Roberts Rules of Oreder.

 - PCPs working on Republican candidate campaigns is not inherently a conflict of interest.
 - Any member of the MCRCC with fiduciary responsibility should avoid any appearance of bias or favoritism when dealing with financial issues.
 - Any member of the MCRCC with fiduciary responsibility must report to the MCRCC any paid work done involving a Republican candidate or other PAC.

• Job duties

- Precinct Committee Person
 - Primary responsibilities of PCPs are to attend Central Committee meetings and vote when called upon.
 - Recruit PCPs

 - Maintain HD PCP contact list.
 - Keep visibility on PCP availability.
 - Keep visibility on PCP volunteer actions.
 - Maintain walking/phone lists for HD.
 - Recruit PCPs
- House District Captain Coordinator
 - Manage the HD Captains
 - Recruit PCPs
- PCP Coordinator
 - Train PCPs
 - Recruit PCPs
- Chain of command for action
 - HD Captain
 - Complaints from PCPs are sent to the PCPs House District Captain. The HD Captain will
 review the complaint and concur/nonconcur with the complaint before forwarding the
 complaint to the |HD Captain Coordinator
 - HD Captain Coordinator
 - Complaints from PCPs forwarded from the House District Captain. The HD Captain Coordinator will review the complaint and concur/nonconcur with the complaint before forwarding the complaint to the Secretary.
 - Secretary
 - The secretary will record the complaint/issue and forward the complaint to the Chair.
 - Chair
 - The Chair will review the complaint and make a determination regarding the complaint.
 - Executive Team
 - Should the PCP disagree with the Chair's decision, the PCP may appeal the decision to the Executive Team.
